

## RVSC BOD January 16, 2014 BOD Meeting Minutes

- 1. Meeting called to order at 6:35 p.m. All board members were present. Also in attendance parents Jennifer Lidberg and Michelle Duren
- 2. Board member appointments: Mary Gombold to Secretary and Jessica Patrick to At Large Board Member.
- 3. Coaches Update: Next meet is NHCP Wonderland at Hamline University Jan. 18 & 19. We will have 17 swimmers attending. The following meet is The Sea Devil's Feb. 8 & 9. Team deadline is Jan. 20. River Falls February 15. Watch for information. Check RVSC web site for Season Champ meets. Overall attendance at practices has been good considering the weather. All swimmers are improving their times. Ellen is coordinating our assistant coaching schedules and making sure all coaching certifications are completed. Coach Sara is going back to school and is not coaching in January. She may return in February or March. No commitment is in place. Two kids wanted to join our club after we were already into the Winter Season. It was discussed that all should join at registration. This topic will be revisited. It also was discussed about allowing a swimmer to "try out" the club prior to joining. We will follow RVSC Bylaws and Team USA rules.
