- 3. Financial Report
  - a. The club is in need of a Treasurer. Steve has contacted someone he knows about the Treasurer position. This individual does not have a swimmer in the club. One other club member is considering the position.
  - b. QuickBooks version is out of date.
  - c. Steve has completed the Intuit application and is waiting for approval so we can process payments.

- e. The NHCP outdoor meet scheduled for June 28 & 29 filled early on June 9. The deadline was June 16. Ellen reserved space at the Eau Clair meet on Saturday, June 28.
- f. Big East meets SCSC is hosting meets on November 1 & 2, January 17 & 18, and May 30 & 31. The Board agreed to have Ellen commit to these dates.
- g. Finals zoning C finals are zoned to Wolf at the Fred Moore pool and MRC's are zoned to STAR in Highland Park
- h. The Go-Pro camera is not currently being used. Mike offered to help get it set up.
