

RVSC BOD November 2013 Meeting Minutes

- 1. Call to order at 6:37PM on 11/11/13 in Osceola, 16 members attending: Rick, Pliscot, Frank, Michelle, Sandy, Mary, Mike, Steve, Jessica, Chad, Chris L., Chris W., Darren, and Ellen (missing the names of 2 that attended)
- 2. Approved Oct. 2013 meeting minutes
- 3. Financial update
 - a. Confirmed Treasurer transfer complete
 - b. Reviewed winter season budget proposal
 - i. AG1 practice times: Tuesdays 6:30 -7:30 and Thursday 6:30-7:15
 - ii. AG2 practice times: Monday 6:30-7:45, Wednesday 6:30-7:45, Thursday 7:15-8
 - iii. Approved tuition schedule
 - iv. Motion to add an additional \$2.50 surcharge per swimmer per meet; reason: to help offset travel and coaching expenses, 6 yes, 1 no, motion carries.
 - c. Reviewed our current contract with Thriva
 - i. New Treasurer prefers to use QuickBooks instead of Thriva
